

## **Event Terms and Conditions**

## 1 These terms

- 1.1 These terms set out the conditions that apply to your registration for, and attendance at, Events advertised by GenTech. Each reference in these terms to:
  - (a) "Event" means the event set out in the Event Schedule and includes any activity run by GenTech or its Third Party Providers which is advertised by GenTech and open to attendance by individuals who register to attend;
  - (b) "**Event Schedule**" means the section of these terms titled 'Event Schedule';
  - (c) "GenTech" means GenTech Seeds Pty Ltd (ACN 608 586 876) and its related entities including Genetic Technologies Limited (ACN 009 212 328);
  - (d) "Inclusions" has the meaning given in the Event Schedule;
  - (e) "**Third Party Provider**" means third party service providers that GenTech engages for accommodation travel, meals, tours and activities for the Event; and
  - (f) "you/your" means the individual or business registering for and/or purchasing tickets or attending an Event.
- 1.2 By registering for an Event, you agree to comply with these terms. If you are booking on behalf of someone else, you must ensure these terms are made available to each person attending prior to the Event.
- 1.3 Third Party Providers may impose additional terms and conditions for certain Events. It is your responsibility to review these additional terms notified to you for the Event carefully before you make a registration.
- 1.4 The Event times in advertising material are indicative only. While we will work to fulfil our proposed itinerary, the final details, times and locations for parts of the Event may change and will be confirmed prior to the Event.

## 2 Events

## 2.1 Your obligations

When participating in or attending an Event, you must comply with these terms, any additional conditions set out in the Event Schedule and all applicable laws.

Appropriate footwear and clothing must be worn at all times during the Event.

## 2.2 **Registration fees**

The registration fee covers entry to the Event and all Inclusions, and any applicable GST.

You must pay the full registration fee amount within 7 days of receipt of a tax invoice to secure your position.



You are responsible for any ancillary costs associated with attending the Event, such as the cost of any travel, travel insurance, mini bar, drinks and any other costs not specified as Inclusions.

#### 2.3 Delay, postponement or cancelation and refunds

### Where you cancel:

- You must notify GenTech in writing as soon as possible if you need to cancel your (a) registration to an Event for any reason. If you have paid a registration fee and you notify GenTech of a cancellation in writing:
  - (i) at least 31 calendar days prior to the date of the Event, GenTech will refund the registration fee in full; and
  - (ii) where notice is given less than 31 calendar days prior to the date of the Event, GenTech will not provide a refund of the registration fee due to the costs committed to Third Party Providers associated with the Event.

## Where GenTech delays, postpones or cancels:

- (b) GenTech may also postpone or cancel an Event at any time. If GenTech postpones or cancels an Event, GenTech will refund any registration fee you have paid.
- (c) GenTech reserves the right to refuse your entry to the Event and/or to remove you from the Event if you fail to comply with these terms or if in the reasonable opinion of GenTech or its Third Party Providers your behaviour is considered unlawful, inappropriate or offensive. In these circumstances, GenTech will not refund any registration fees.

#### 2.4 **Events at Risky Sites**

Events may be held at sites that present health and safety risks, such as sites that contain animals, heavy machinery or which are located in areas that are prone to natural disasters such as fires or floods ("Risky Sites").

When attending Events at Risky Sites you acknowledge that you will be subject to any additional rules, policies, procedures and directions provided by GenTech or the Third Party Provider.

You attend Events at Risky Sites at your own risk and bear all liability including damage or loss that you may incur to your person or property. To the extent permitted by law, by entering a Risky Site you release GenTech and the Third Party Provider of the Risky Site from all claims and liability in connection with your attendance at a Risky Site.

#### 2.5 **Limitation of liability**

While GenTech will take reasonable measures to ensure the safety of its Events, you attend the Event at your own risk. To the extent permitted by law, GenTech will not be liable for any damage or loss suffered or incurred by you (including damage to property, injuries or illness) as a result of your attendance at an Event.

To the extent permitted by law, GenTech is not responsible for any act or omission of a Third Party Provider (whether negligent or otherwise) and GenTech will not be liable for injury, damage, or loss caused by an act or omission of a Third Party Provider.



#### 3 **Privacy**

#### 3.1 Consent to collection and use of personal information

GenTech will manage any personal information that it collects through your registration or at an Event in accordance with GenTech's Privacy Policy, which you can access at: Privacy Policy -**Pioneer Seeds** 

By attending an Event or by submitting any information to GenTech, you agree to the collection and use by GenTech of your personal information in accordance with the Privacy Policy.

#### 3.2 Disclosure of personal information to third parties

You consent to GenTech disclosing your personal information to third parties for the purpose of registering, booking and providing the Event, including the Third Party Providers and the payment system provider that processes payments. Where GenTech provides your personal information to any organisation, the organisation will be obliged to handle your personal information in accordance with applicable privacy laws.

#### 3.3 Consent for marketing purposes

GenTech reserves the right to use all or part of any material (photographs, film footage, or any detail) generated during the Event for the purpose of the Event, or for publication online, in print or other broadcast media (including social media), for publicity, promotional materials or campaigns related to the event or similar events in the future. Please advise a team member if you do not wish for your image to be used.

#### 4 General

#### 4.1 Survival of terms

All provisions of these terms that by their nature should survive completion of the Event will survive, including all limitations on liability, releases and disclaimers.

#### 4.2 **Australian Consumer Law**

Nothing in these terms and conditions will operate to exclude, restrict or modify any provisions in the Australian Consumer Law or any equivalent Australian state or territory legislation, the exercise of a right conferred by such a provision or any liability of GenTech for a breach of a condition or warranty implied by such a provision, where it is unlawful to do so.

#### 4.3 **Governing law**

These terms are governed by the laws of Victoria, Australia and will be subject to the nonexclusive jurisdiction of the courts in Victoria, Australia.
